2020 Biosecurity Protocols / Statement of Health

Hudson Valley Show Jumping is dedicated to the health, welfare and safety of all exhibitors both equine and human. To protect our equine partners, we will be enforcing the following protocols at all Hudson Valley Show Jumping horse shows.

- A current (within 12 months) negative Coggins test is required.
- Proof of Vaccinations (per the USEF GR-845 Equine Vaccination Rule [CHAPTER 8F Welfare of the Horse] Rule Changes Effective 12/1/15)
- Horses entering the grounds must be accompanied by documentation of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within six months prior to entering the show grounds.

By signing below, I testify that the horse listed on this entry has:

- 1) Been enrolled in a regular and consistent program of vaccination against EHV-4/1 with the most recent booster being within 120 days.
- 2) Has not shown symptoms of or been treated for EHV-4/1 within the past 28 days.
- 3) Has not been exposed to any horse or ponies that have been treated for or shown symptoms of EHV 4/1 within the past 28 days.
- 4) Has not had a temperature greater than 100.5 in the last 28 days.

USEF Member Statement:

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$45 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot (exception: Friesian performance FR222) and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.

Covid 19 Safety Protocols

Hudson Valley Show Jumping and Crosswinds Equestrian Center are committed to keeping horse shows fun and safe during Covid 19. Please read and follow all protocols to help us ensure the safety and well-being of all parties involved in our events.

1. Please follow social distancing guidelines recommended by New York State and the CDC, this includes keeping 6 feet distance between persons.
2. If you are currently not feeling well, have been in contact with someone who has tested positive or is suspected positive in the last 14 days, or are currently awaiting tests results we ask that you please stay home.
3. All persons attending the show must wear masks at all times when not mounted. This includes riders, trainers, grooms, children, staff, etc.
4. Please limit the amount of people affiliated with each rider to essential personnel only. Junior riders may have a parent or guardian, however this is not the time to be bringing the whole family to spectate.
5. One person in the show office at a time and we ask that exhibitors and trainers complete as much of their office work electronically ahead of time if possible.
6. Please complete the new Crosswind Equestrian Center waiver prior to arriving at the show. All personnel, including riders, trainers and grooms must complete this waiver. It can be submitted with your entries.
7. As much as we love spending time with our horse show friends, we ask that you please limit your time at the venue as much as possible. We will be continually updating start times on www.horseshowsonline.com and encourage you to check in to determine when your classes will be running.

May not cross enter into any division except Pleasure.*

Academy Equitation

Open to riders not ready to show in Short/Long Stirrup. May not cross enter into any other division, except Pleasure.

Pleasure Horse/Pony

Open to all. To be shown at walk, trot and canter.

36, 37, 38. Pleasure Horse/Pony-Under Saddle

Lead Line

Open to riders under 8 years old. Must be accompanied by handler over 16 years of age.

39. Leadline- Walk only \$15

40. Leadline- Walk, Trot \$15

Beginner Hunter

Open to all horses and riders. Fences 2'.

32, 33, 34. Beginner Hunter- Over Fences

35. Beginner Hunter- Under Saddle

Modified Equitation

Open to Junior and Amateur riders. Fences 2' (May not cross enter into Child/Adult Equitation).

58. Modified Equitation- Flat

RULES & REGULATIONS

1. Every class offered herein which is covered by the rules and specifications of the current USEF Rule Book will be conducted and judged in accordance therewith.
2. Riders must wear protective headgear in accordance with GR801 at all times while mounted. No exceptions.
3. Management reserves the right to cancel, combine or divide any class if entries warrant.
4. Prize money will be paid by check within 30 days of the competition. Tax Payer ID or Social Security number required to receive prize money. Prize money subject to change if number of entries is less than 10.
5. Dogs must be on a leash at all times.
6. Longing only in designated area.
7. Competition arena 110 x 220', warm up arena 125 x 220". Both arenas have technical sand/fiber footing.
8. Entries must be received by September 30. Entries received after the closing date will be accepted with a \$50 post entry fee.
9. Entries may be mailed, faxed, or submitted through www.horseshowsonline.com
10. Horse show to follow current USEF regulations, including biosecurity.
11. All riders, including non-competing, must complete a release form. Back numbers will not be released without signed release form and form of payment.
12. \$50 for non showing horses.
13. Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. ***The parent(s), legal guardian(s), or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation.*** Violations of this rule will cause for sanctions against the parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule. (If your competition bans motorized vehicles, please contact our office for further instruction.)

STABLING

Stabling requests and payment in full must be received by the horseshow office by December 6 to be guaranteed.

- Stalls are permanent or temporary with doors.
- Stalls are \$150 for the show, available Friday - Sunday.
